Brief Overview of Northstar Care for Children



Overview

- Effective Jan. 1, 2015
 - Northstar Foster Care
 - Northstar Adoption Assistance
 - Northstar Kinship Assistance
- New Title IV-E financial program for custody transfers
 - Replaced relative custody assistance
 - Follows federal IVE regulations regarding TPLPCs, which requires relative custodians to be licensed foster parents for at least 6 consecutive months while a child has been placed in their care
 - MN interprets 6 months to be at least one day in a calendar month with licensed, relative custodian

Northstar Funding Streams

- Northstar benefits can be:
 - Title IV-E (federal, state, local shares)
 - Non Title IV-E (state and local shares only)
- Agencies must determine Title IV-E eligibility before considering non Title IV-E
 - Title IV-E determined at time of removal
 - AFDC requirements
- Non Title IV-E Medicaid implications Kinship & Adoption

Agencies Involved

Financially responsible agency

- Completes forms in SSIS
 - Approves MAPCY, enters eligibility determinations, creates BA

Legally responsible agency

- Provides information and documentation, as needed
- Makes placement decisions, files petitions, court jurisdiction

Minnesota Department of Children, Youth, & Families

Reviews and confirms forms

<u>Licensing Agency / Child Placing Agency</u>

Public Private Permanency Collaborative (PPPC)

General Eligibility, Process, & Timelines



Eligibility

- Child is US citizen/immigration status
- Child is under 18 years of age
 - NAA 18-20, depends on jurisdiction
- Cleared AW BGS for all required individuals
- Child lived with licensed prospective relative custodian for 6 consecutive months (NKA only)
 - Federal requirement IVE funding
- Benefit agreement in place prior to finalization
- Option to decline benefits

TPLPC

Adoption

- Must be to a relative
 - Living in and outside of Minnesota must be considered
- Agency has consulted with the child, if age 14+, about permanency
- Agency determined:
 - Reunification & adoption are not appropriate;
 - Strong attachment to the relative; and
 - The relative is committed to caring permanently for the child.

- Special needs determination
 - Child cannot/should not return home, attempted to place w/o NAA, & a barrier to adoption w/o NAA:
 - **↓** SSI benefits
 - ↓ Documented disability
 - ↓ Member of sibling group
 - ↓ Adopted by parent who previously adopted sibling
 - ↓ At risk of developing a disability
- Child, age 14+, must consent to adoption
- Must be legally free

TPLPC

Adoption

- Primary rights & responsibilities
 - Legal relationship is maintained w/ birth parents
 - Inheritance, visitation, access to certain information, etc.
- Ends when child turns 18
- Child's name remains the same
- Child support may continue

- Equal to birth parents rights
- Permanent, lifelong relationship
- Inheritance
- Determine child's name
- No child support from birth parents
- Tax credit, maybe

General Process

Kinship

- Kinship / Tribal Placement
 Agreement
 - Filed w/ TPLPC petition
- Eligibility Determination
- Benefit Agreement
- Finalization

Adoption

- Adoption Placement Agreement
 - Filed w/ Adoption petition
 - DCYF approval if under guardianship
- Eligibility Determination
- Benefit Agreement
- Finalization

Required Documents – Kinship

- Kinship Placement Agreement
 - Can be signed on or after date of approved foster care home study & approved relative custodian BGS
 - Contains required determinations for NKA eligibility
- Current MAPCY
 - Approved within 1 year of ED submission
- Removal Method
 - Court order or VPA

- CFC license
 - ICPC approval, if applicable
- All required AW BGS
- Child's birth certificate
 - Citizenship
- AFDC worksheet
 - Completed at the time of foster care placement
 - Used for Title IV-E & non Title IV-E eligibility

Required Documents – APA

- Adoption Placement Agreement
 - Can be signed on or after date of approved adoption home study & approved BGS and child is legally free
 - Can be signed based on intent, not location
 - Fully executed once signed by prospective adoptive parent(s), legally responsible agency, and DCYF
- Adoption Placement Decision Summary
 - If using OHPP for sections A and B, need to include OHPP
- AW BGS for all required household members

- CFC license (if using a foster care AW – BGS)
 - If married couple, both have to be on the APA & CFC license
 - Exemption
- Child's social and medical history document
- Sibling separation court order (if applicable)

APDS – Section C

C. Relative search and placement consideration

County social services agencies have a duty to search for, notify, and engage relatives of children in out-of-home placement. A child's relatives must be considered for adoptive placement prior to considering unrelated individuals. Additionally, individuals related to a child by blood, marriage, or adoption, including legal parents, guardians, or custodians of a child's sibling, must be considered for adoptive placement **before** considering individuals who are important friends or who have significant relationships with a child or their family. Adult siblings of children in foster care have an additional right to be considered for adoptive placement, and must receive notice of this right per the Foster Care Sibling Bill of Rights. [Minn. Stat., sections 260C.008; 260C.212, subd. 2(a); 260C.221; 260C.605, subd. 1(b); and 260C.613, subd. 1(b)]

3. Provide a summary of relative search and placement consideration efforts below. Include: search method/s, individuals contacted, responses received, and how the agency considered each relative who indicated interest in being a placement and/or permanency resource. If a relative search was **not** completed, and/or relatives were **not** considered in the specified order, provide an explanation and attach supporting documentation.

Required Documents – Adoption ED

- Removal order or VPA
- Disability documentation (if applicable)
- MAPCY Rating Report
- Title IV-E Foster Care AFDC Relatedness Worksheet (non-applicable)
- Adoption assistance in prior adoption (if applicable)
- SSIS will prompt documents needed

Title IV-E Requirements

<u>Kinship</u>

- Court Order or VPA
 - If court order for removal, need contrary to welfare statement.
- Child lived with <u>licensed</u> prospective relative custodian for 6 consecutive months & eligible for Title IV-E foster care payments.

A sibling of a Title IV-E eligible child <u>do not</u> need to meet the Title IV-E eligibility criteria, as long as the child is placed with the same relative custodian and the agency agrees it is in the child's best interests.

Adoption

- Court Order or VPA
- If court order for removal, need contrary to welfare statement.
- Child's removal home meets AFDC eligibility criteria.
 - Depends on age of the child

Non Title IV-E Requirements

Kinship

- If court order for removal, no contrary to the welfare statement.
- Not eligible for Title IV-E foster care payments.
- If an exemption is granted.

Exemptions are very rare & can be to:

- Licensing requirement; or
- Living in the home for a min. of 6 consecutive months while licensed.

Adoption

- Child's removal home did not meet AFDC eligibility criteria.
 - Depends on age of the child

Benefits

18

- Statement to Decline NAA & NKA
- Four main benefits:
 - Basic payment
 - Age of child
 - Child's food, clothing, shelter, and daily supervision
 - Supplemental payment
 - MAPCY
 - Extra care and attention needed to meet child's needs
 - At-Risk Adoption Assistance No monthly payment
 - Medical Assistance (Medicaid)
 - Reimbursement of nonrecurring expenses associated with finalizing
 - NAA Vehicle & Home Modification benefit

Benefit Rates

Preschool Rate

- ½ of the rate that the child would receive in foster care
 - If finalize at preschool rate, preschool rate remains even with reassessment / rate adjustment post-finalization
 - Determined when benefit agreement is signed by pre-adoptive parent(s) or by relative caregiver(s)

School Age Rate

Full rate that the child would receive in foster care

Kinship Assistance

 Automatic eligibility for Medicaid

Adoption Assistance

- Automatic eligibility for Medicaid
- Out-of-state = state dependent

Kinship Assistance

- Automatic eligibility for Medicaid in MN
- Out-of-state = state dependent

Timeframe

Kinship

- Kinship / Tribal Placement
 Agreement
- Eligibility Determination
 - 3-4 weeks after submission
- Benefit Agreement
 - 24-48 hours after submission

Adoption

- Adoption Placement Agreement
 - 6-8 weeks after submission
- Eligibility Determination
 - 3-4 weeks after submission
- Benefit Agreement
 - 24-48 hours after submission

Timeframe

- DCYF (Records & Eligibility) process items by order received
 - Complete submissions All required documents must be sent in order to start review
- Expedited requests
 - Special circumstances may be processed by "urgency" if communicated
 - Examples Youth close to turning 18 & significant medical implication (not long to live)
- For siblings under different court jurisdictions being adopted by the same family, all submissions are reviewed and approved at same time
- Can go back and forth between agency & DCYF with correction requests

DCYF Update



DCYF Update

- Child Safety and Permanency moved from DCYF to DCYF on July 31, 2024.
 - New staff phone numbers effective 8/28/2024 & general email changes (i.e. SSIS help desk)
 - CSP is now its own Administration under DCYF vs a division in DCYF
- Minnesota Statutes Chapter 256N changed to 142A. Minnesota Statutes, Chapter 260C remained the same.
- The Social Services Information System (SSIS) has been updated so that template documents reflect these changes. State Court Administration is in the process of updating its order templates to reflect these changes as well.
- Northstar Adoption Assistance and Northstar Kinship Assistance benefit agreements created on or after July 1, 2024, need to reflect DCYF and updated 256N statutes.

DCYF Update

- Guardianship orders signed on or after July 1, 2024, need to have guardianship transferred to the Commissioner of DCYF.
- Guardianship orders signed prior to July 1, 2024, do not need to be updated because the children involved in those matters are considered automatically transferred to and under the guardianship of the Commissioner of DCYF as of July 1, 2024.
- Adoption petitions, decrees, and placement agreements signed on or after July 1, 2024, need to reflect DCYF.
- Adoption petitions and placement agreements signed prior to July 1, 2024, do not need to be updated
 because children involved in those matters are also considered automatically transferred to and under the
 guardianship of the Commissioner of DCYF as of July 1, 2024.
- When finalizing an adoption, it is important that the adoption decree reference the new DCYF.

Legislative Updates – Permanency



Chapter 117

- Established the MN African American Family Preservation & Child Welfare Disproportionality Act
 - Hennepin and Ramsey –January 1, 2025
 - Statewide –January 1, 2027
- Reestablishment of Parental Rights Modifications
- Sections 14-15 Effective January 1, 2025, for Hennepin/Ramsey (or if county ops in) and January 1, 2027, statewide
- Modifies chapter 260C to allows children ages 10 or older, responsible social service agencies, and guardians ad litem to file petitions to reestablish parental rights and reduces the length of time a child must have been in foster care following a termination of parental rights order for a reestablishment petition to be filed (from 48 months to 24 months).

Applicable Age

- Between October 1, 2023, and September 30, 2024, the applicable age is 2.
- Starting July 1, 2024, the final step of the applicable age phase-in takes effect, making all children eligible for IV-E adoption assistance regardless of age.
- Eligibility determinations made on or after July 1, 2024, will automatically assign a child of any age as an "applicable child" in SSIS
 - If a benefit agreement is signed on or after July 1, 2024, the child be an applicable child. In this situation, the department will inactivate the original ED so that a new one may be submitted & the child properly assigned "applicable child." This process will need to occur before the BA is fully executed.
 - If the benefit agreement was signed before July 1, 2024, the child will be a non-applicable child.

Tips & Tricks



Questions from the Bench

"Waiting for DCYF"

- Date of submission
- What was submitted
- Licensing process / status
- Preschool & School age rate delay
- ICPC initiated / status

- Is it in data/document correction and if so, what is DCYF asking for
- Have you submitted APA and/or ED back to DCYF for approval
 - Data/Document correction request
- Have you followed up with assigned R&E worker
 - Status check 3 weeks after submission

Common Issues

33

- Paperwork errors
 - Missing pages, placement agreements signed before requirements met, incorrect names
- SSIS errors
 - Incorrect data entry
 - Continuous placement dates, names, ICWA, etc
 - MAPCY sent vs MAPCY selected in ED
 - Submitting eligibility determination prior to 6 month requirement
 - Data fixes

- Background studies
 - Adoption AW BGS older than 1 year
- ICWA inquiry & notice
 - QEW, if required
- Relative search
- Child's social and medical history incomplete & not current

Common Issues

- Court Orders
 - Missing required language
 - Not deferring court orders (if applicable NKA)
 - Addressing both parents in TPR
 - Alleged/presumed fathers; status addressed but don't need to TPR; no parental rights to TPR
 - Any/Unknown Not required
 - Documentation of extenuating circumstances if removal date & initial order with the CWS finding don't coincide
 - IV-E eligibility / requirement

Licensing

- Misspelled names on CFC license and AW – BGS
- Address not matching CFC license
- Timeliness with licensing process
- Missing prospective relative custodians on KPA
- All pre-adoptive / relative custodians on KPA / APA must be on the CFC license, if CFC AW – BGS are being submitted
